Background and Purpose

The Cruz Reynoso Bar Association (CRBA) is a professional organization that was founded to advocate for the legal interests of the Latinx community and to maintain the positive image of the Latinx bar in the Sacramento area. As part of its community service mission, CRBA awards scholarships to law students who demonstrate strong ties to the Sacramento Latinx community and wish to practice law in the Sacramento area upon graduation.

The CRBA Scholarship Committee will review all applications for the CRBA \$1,000 Scholarship Award. The CRBA UNITY Bar scholarship will be awarded at the UNITY Bar Dinner, which will take place on October 30, 2019 in Sacramento. The winner of the scholarship will be provided a ticket to attend the Unity Bar Dinner and is encouraged to attend.

Eligibility and Merit Criteria

To be eligible for the scholarship, at the time you apply, you must be currently enrolled and in good standing in any year of law school at: Lincoln Law School, McGeorge School of Law, or U.C. Davis' King Hall.

Applicants will be evaluated holistically with emphasis on the following merit criteria:

- Active student participation in activities, projects, or organizations that serve the community, especially those that focus on areas that impact the Latinx community. We view this category as the most significant for the purpose of this scholarship;
- Participation in the local legal community, including at CRBA events, membership in relevant law school organizations and/or volunteering in other legal community service projects;
- Academic achievement in law school; and
- Financial need.

Application Evaluation

The Scholarship Committee will evaluate each scholarship applicant and will select the scholarship recipient. To facilitate the decision-making process, the Scholarship Committee may, in its discretion, require a personal interview with any or all scholarship applicants.

You may include information regarding your background, reasons for pursuing further education, challenges you face outside of school, legal field of interest, career goals, any special circumstances, your financial need, and any other information you would like considered by the scholarship selection committee.
